This allows for Decorah Parks & Recreation and Winneshiek County Conservation to review and approve/deny the request and rule out scheduling conflicts.

## Trout Run Trail & Other Public Trails Special Event Rules:

- Please inform your participants to be respectful of others. The trail is always open to the public; special events do not mean the trail is reserved for your event exclusively.
- No unauthorized motorized vehicles (i.e. ATV's or golf carts) allowed on the trail. Authorized vehicles are official maintenance and emergency vehicles only.
- Paved trails: acceptable competitive racing includes runs, walks. Off-road trails: acceptable competitive racing includes runs, walks, biking.
- The event committee is required to clean and dispose of event-generated debris including any warning/informational signage immediately following the event.
- No painting is allowed on the trail; chalk is allowed for race markings.
- No equipment and/or materials shall interfere with the movement of pedestrians or bicyclists on the trail surface at anytime during special events.

## When is a Special Events Permit required from the City Clerk's Office?

- The site or area requested has not been designated as a normal site for large group gatherings.
- Admission is controlled either by donations, entry fees, or tickets.
- Anything is sold.
- Tents, canopies or stages are brought in.
- The event is advertised as a public event.
- The event requires a catering company.
- Additional restroom or garbage facilities are required.
